Note that there are "*Generation*" and "*Transmission*" tabs for completion as applicable. If you had previously provided information for NPCC's BES Survey update, you may transpose your latest information into the applicable tabs.

For Company Profile information (Cell E9), please provide your latest information as if you were filling out the Pre-Audit Survey for an audit. You may provide this information in a separate Word document if you refer to it in Cell E9 and ensure that the separate document contains "CompanyProfile" in the file name.
