NPCC Members and Entities of the NERC Registered Ballot Body,

The NPCC Regional Standards Committee has reviewed the subject standard and related materials currently posted for an "Initial" Ballot through 8pm January 8th, 2016. The RSC and NPCC Staff have worked closely with the NERC Standard Drafting Team who developed this latest draft of the standard and we have effectuated important cost effective revisions to the standard, notably the recognition that some RAS are local in nature and not of any appreciable impact to the BES. As such, these local RAS should be treated differently than those whose potential impact due to misoperation or inadvertent operation represent a more significant reliability impact to the BES.

The RSC and NPCC Task Forces have not identified any further issues precluding support for this standard so NPCC recommends an **Affirmative** vote to accept the standard and a positive opinion for the non-binding poll.
