NPCC Members of the NERC Registered Ballot Body,

The subject standards are posted for ballot through 8 pm July 28th, 2014. This project is a subset of a much larger effort underway to review all the Generator Owner applicable standards to identify the effects on Dispersed Power smaller generators such as wind turbines, solar, etc. The standards are being revised where appropriate to ensure that wherever these smaller units are aggregated at a collector bus, the associated standard requirements are appropriately reviewed and revised.

The Regional Standards Committee has reviewed the posted standard and the majority of members will vote to accept the standards as proposed. NPCC as the regional entity, has also reviewed the standards and finds no detriment to reliability. NPCC will be voting **Affirmative** on the set of standards and has been participating in the drafting team's activities.
