NPCC Members and Entities of the NERC Registered Ballot Body,

The NPCC Regional Standards Committee (RSC) has reviewed the subject standards and discussed issues related to the standard and ballot which is open until 8pm on Monday August 15, 2016 as noted below.

The RSC has not reached a full consensus ballot position on EOP-005-3.

RSC Members have indicated the following concerns:

- 1) More clarity surrounding the type of system modifications that would require an update to the restoration plan.
- 2) Re verification of the restoration plan should be consistent with the recommendations of the *FERC-NERC Regional Entity Joint Review of Restoration and Recovery Plans*.
- 3) More clarity regarding the effective date of an updated TOP restoration plan.

NPCC as the Regional Entity will be casting an 'Affirmative' vote on EOP-006-3 and EOP-008-2 and a 'Negative' vote on EOP-005-3.

NPCC will continue to coordinate its concerns through its representative on the Standard Drafting Team.
